Dear Dr. and Ms. Levinthal:

My firm serves as general counsel for Hinsdale Township High School District No. 86, and I work with the District on FOIA matters. I am responsible for providing this supplemental FOIA response and information to you, in consultation with the District's FOIA Officer and Superintendent.

This email and attachments are in response to Ms. Levinthal's follow up FOIA request dated December 17, 2019, and in response to Dr. Levinthal's emails concerning the District's alleged untimeliness in responding to your FOIA request submitted on December 3<sup>rd</sup>, amended after hours on December 6<sup>th</sup>, to which the District responded on December 16<sup>th</sup>.

First, in response to Ms. Levinthal's follow up request, attached to this email is a PDF copy of the live Google Form referenced and attached to Ms. Gaubatz's November 1, 2019 email. This is the same Google Form that is referenced in Ms. Gaubatz's November 6, 2019 email, and which was accessible via a live link via the responsive records previously released. In response to Ms. Levinthal's remaining request, we have reattached Ms. Gaubatz's email from November 11, 2019, as this email references the only survey results that were released: the names of those who completed the survey, what district they are from, and their district email address. Please kindly note that there was no attachment to this email. In regard to the remaining survey results, which were clearly not responsive to Dr. Levinthal's initial request, please be advised it is the District's practice to withhold survey results and related documentation as they are exempt under FOIA Section 7(1)(f), which exempts "[p]reliminary drafts, notes, recommendations, memoranda and other records in which opinions are expressed, or policies or actions are formulated, except that a specific record or relevant portion of a record shall not be exempt when the record is publicly cited and identified by the head of the public body." 5 ILCS 140/7(1)(f); see also 5 ILCS 140/7(1)(c); Harwood v. McDonough, 344 Ill. App. 3d 242 (1st Dist. 2003). Citing the need to encourage survey respondents to provide frank and open feedback, as well as to prevent public bodies from being discouraged to solicit such feedback, the Illinois Attorney General's office has repeatedly found that school district survey results are covered by the exemption at Section 7(1)(f). See, e.g., 2010 PAC 6961 (comments on school district climate survey were exempt); 2010 PAC 9980 (parent surveys regarding student athletics were exempt); 2011 PAC 11835 (results of special education parent survey were exempt); 2011 PAC 13448 (employee opinion survey results were exempt); 2011 PAC 14058 (survey comments were exempt); 2011 PAC 14928 (climate survey responses from parents were exempt); 2012 PAC 20492 (survey raw data results were exempt); 2016 PAC 44309 and 2016 PAC 44311 (survey takers' opinions and raw data were exempt because the responses were used in the District's decision-making process); 2017 PAC 50257 (survey raw data and comments from members of the public gathered by a school district were exempt, notwithstanding the district's publication of general summaries of the survey information, where those specific data and comments were not publicly cited and identified); 2018 PAC 53747 (community survey raw data was exempt).

As to timeliness, I believe the District's December 16<sup>th</sup> response was timely, and I do not believe it was improper for the District to count the deadline from its receipt of your amended request. However, the issue is moot, as even if the deadline were calculated from your original request of December 3<sup>rd</sup>, the District was entitled to take an extension, and the District's extended response would have been due on December 17<sup>th</sup>, which was after the date you actually received the District's response. Please note that when you informed Ms. Kedrowski you were not able to access the records on December 16th, she took the time to make sure you had the records the same evening, responding to your email at 9:03 p.m. letting you know the records were re-posted and attached to her email. Ms. Kedrowski also gave you her cell phone number and clearly went above and beyond in responding to your request.

Not only was the timing of the District's response lawful, but I believe it is baseless to allege that any District employee or agent would falsify any timestamps. It would be unnecessary for the District to do so, as explained above. The District has, however, confirmed that you were told the records were available before they actually became available, due to an issue with the District's FOIA management software that the District is fixing now that it has come to the District's attention. While we appreciate your bringing this to the District's attention, your accompanying allegations of improper conduct by District employees are without basis.

From my work with the District, I can tell you firsthand that the District is committed to its community members and remaining transparent, consistent with the confidentiality concerns stated under FOIA and other laws. However, to the extent you disagree, you may have a right to have the District's response(s) reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. 5 ILCS 140/9.5(a). You can file your Request for Review with the PAC by writing to:

If you choose to file a Request for Review with the PAC, you must do so within 60 calendar days. 5 ILCS 140/9.5(a). Please note that you must include a copy of your original FOIA request and the District's response(s) when filing a Request for Review with the PAC. You also have the right to seek judicial review of any denial by filing a lawsuit in the State circuit court. 5 ILCS 140/11.


